TERMS AND CONDITIONS - EXHIBITORS

01. 20th India International Seafood Show 2016 will be Organised in Port Trust Diamond Jubilee Stadium, Visakhapatnam, Andhra Pradesh, India from 23rd to 25th September 2016.
02. The Exhibitors shall adhere to the Exhibition manual (Available in Website: www.indianseafoodexpo.com)
03. The Organisers will provide standard fascia with company name, one power outlet of 15 amps (220 volts), one table, 3 chairs per stall of 9 sq. m. under shell scheme.
04. Two Delegates Passes will be issued for every stall (9 sq. m.) booked.
05. Exhibitors not opting for shell scheme need to inform the Organisers by 31st August 2016 along with a layout plan for approval.
06. Lunch will be provided to the Delegates on Show Days on producing the designated coupons/smart card issued at registration.
07. 25 Visitor Passes will be issued per Exhibitor. Passes will be valid for Single Entry Only.
08. Stalls will be allotted on a first-come-first served basis.
09. Fee once paid will not be refunded.
10. The Exhibitors may book any number of stalls.
11. You may order additional furniture / other items / additional electricity requirement directly with the official stall contractor. Extra charges apply for continuous power requirement and for additional items.
12. For raw space the stall will be handed over to the Exhibitors on 21 / 09 / 2016 at 8.00 am and for shell scheme the stall will be handed over to Exhibitor on 22 / 09 / 2016 at 10:00 am.
13. Furnishing shall be completed and all materials that are not for use in the stall be removed by 18.00 hrs on 22/ 09 / 2016.
14. The name of the Exhibitor registered on or before 31st August 2016 only will be published in the show catalogue.
15. Show Timings: 10:00 am - 06:00 pm (23rd & 24th September 2016)
10:00 am - 04:00 pm (25th September 2016).
16. Stall Delegates are entitled to participate in the technical sessions arranged by the Organisers.
17. Confirmation of Stall Reservations will be sent by E-mail/Post.
18. Though the Fair Authorities will be providing general security, the fair authorities will not be responsible for any damage / loss of any article / property kept in the stall.
